
Pelican Rapids Bicycle and Pedestrian Plan

Fergus Falls Bicycle Pedestrian Plan

We're glad to announce that work on the City of Fergus Falls' Bicycle and Pedestrian Master Plan has begun! A Request for Proposal process has been completed and a consultant has been selected and hired.

The consultant is working with the newly-assembled Project Steering Committee ([PSC](#)) and City Staff to develop an initial inventory of existing walk / bike assets in the City, engage Fergus Falls residents in providing guidance to the plan, and prepare recommendations for improving walking and biking in the City.
